1. WELCOME AND INTRODUCTIONS – Paul McNair

Meeting was called to order at 3:04pm EST.

2. VERIFICATION OF QUORUM – Paul McNair

Participants were asked to put their full name and organization in the chat to confirm quorum. See Appendix A for a list of those in attendance.

3. APPROVAL OF AGENDA - Paul McNair

2022-1: Motion to approve the agenda as presented. Moved by Greg Wickware, seconded by Justin Thompson. Approved by consensus.

4. CHAIR'S REPORT – Renata Woodward

Significant Activities (past year)

- The ACLT Board met on a bi-weekly and later monthly basis to legally register the alliance and develop by-laws, governance policies, a fundraising strategy, budgets, and a case for support.
- Partner meetings included NCC, DUC, CLC, WHC, Nature Canada, the Green Budget
 Coalition, COP15 national environmental group coalition and COP15 Quebec collectif,
 several indigenous groups, government representatives, MPs and as you might have
 seen in the recent newsletter, the work of Canadian land trusts was recently
 recognized in a parliamentary session.
- ACLT together with the provincial alliances hosted a national summit.
- Renata attended the Quebec conference les ateliers sur la conservation des milieux naturales.
- The ACLT Board has been developing a strategic plan. Renata shared highlights of the working document including Purpose, Mission, Vision and Theory of Change.

Financial Standing

- Since this is the first year of operations, there are no financial statements to share with members.
- The ACLT finances/budget have been managed by the Land Trust Alliance of British Columbia.
- ACLT was able to raise funds for a part-time ED and to cover some expenses of the summit.
- The ACLT fiscal year is from September 30 October 1.
- Starting in October 2023, ACLT will be managing its own finances.

5. CANADIAN LAND TRUST WORKING GROUP REPORT – Justin Thompson

Background – A four-year journey

- The group consists of representatives from alliances and executive directors from land trusts across Canada.
- The purpose of the group is to secure / spearhead additional federal funding for land trusts.
- Over 4 years ago ECCC announced funding through NHCP with an LTCF component to fund community and regional land Trusts.
- The CLTWG worked with ECCC, DUC and NCC under the NHCP and were able to increase funding from 1M under the old model, to 4.4M annually under LTCF for securement specific projects.
- A strong relationship was built with WHC to deliver LTCF and hopefully more programs in the future.

Successes of LCTF – A huge increase in delivery outcomes and metrics

- Total funding was 20M or 5M/year over 4 years (4.4M/year for securement).
- 166 projects in 7 provinces were funded. 13,500 hectares protected. 40 individual land trusts were supported and 80M in matching funds was raised.

Next Steps

- The group is hopeful that there will be a 3-year renewal of the LCTF program, with similar funding levels/targets to the current program, that will include a CA with WHC, giving ACLT and WHC more control over program design and delivery.
- The goal is to increase the membership and work of the group.

As per the ACLT by-laws (#27) the board shall consist of up to 12 directors represented by 5 appointed directors from each region (Atlantic, Quebec, Ontario, Prairies and British Columbia) as voted by provincial alliance members or other collective means where no provincial alliance

exists. Each region with a provincial alliance will be entitled to 1 additional board representative determined by the respective alliance board. The ACLT board may appoint up to 4 skills-based directors who must represent at least 3 of 5 regions. Representatives from First Nations and other aligned organizations will be encouraged.
